## Rise Up, Women

### The Struggle for Women's Suffrage

7:00 pm

Wednesday, March 16, 2016

St. Andrew's Presbyterian Church

1601 Mary Drive, Pleasant Hill

At our March General Meeting Phyllis Bratt will talk about the long, arduous journey to achieve the women's right to vote both in Britain and America. Frustration with the movement's lack of progress in England prompted Emmeline Pankhurst and her daughters to adopt militant tactics included picketing politicians, burning buildings, breaking windows, destroying pillar boxes and organizing large exhibitions designed to bring their fight to the public. The colors purple, white and green became the symbols of the fight.

One of Mrs. Pankhurst's American followers was Alice Paul, who traveled to London to take part in the protests. She joined many suffragettes in Holloway Prison, went on a hunger strike and was forcibly fed. She learned from her experiences how to generate publicity for the cause and brought her knowledge back to America, where she introduced those tactics. Alice founded the National Women's Party in 1916. Phyllis will tell the stories of these amazing women to whom we owe a huge debt of gratitude.

Phyllis Bratt lived in London from 1992 to 1995. She became interested in the suffrage movement after viewing the Museum of London's 1992 exhibition called "The Purple, White and Green, Suffragettes in London 1906-1914." While in London Phyllis began her own collection of suffrage memorabilia. After returning to California, she added items from the American movement to her collection which today includes more than 700 postcards, newspapers and magazines, handbills, photographs, sheet music, china, buttons, badges, stationery, and playing cards and games. The centerpieces of the collection are the hunger strike medal of Edith Downing, a Welsh artist and suffragette, and a china tea set designed by Sylvia Pankhurst for a 1908 exhibition in London.

### **Contra Costa Tackles Truancy**

Laws in California have traditionally required parents to see to it that their children attend school regularly, but the law leaves the enforcement to local school districts or to counties.

As of this school year, Contra Costa County has initiated a program which is designed to intervene and provide support to families rather than punishing parents for student absences and tardies, as had been the case previously. The program consists of a "truancy court" which handles cases of students 12 years old and younger who are chronically absent and tardy. The age limit is stipulated because children at this level are too young to bear the responsibility of getting themselves to school and of arriving on time. Further, it is believed that developing good school attendance habits while young will carry on to the higher grade levels.

Students who miss 10% or more of the school year are considered chronically truant and are referred to district attorney Laura Delehunt who determines whether to issue an "infraction", which brings fines and requires payment of court costs, and then sends the case to truancy court. Judge Rebecca Hardie has the capability of sending the family for services such as parenting classes, counseling, substance abuse programs, etc. The goal of the program is to attack the problems that are preventing children from attending school regularly.

California Attorney General, Kamala Harris, reported that in Contra Costa County, in 2013-14, 30.4 per cent of children in grades k-5 met the Education Code's definition of truancy. It is difficult to calculate the huge drain such truancy has on society, with eventual student attrition, gang involvement, inability to find work, incarceration not to mention the tremendous waste of human potential. Hopefully the truancy court will have the desired effect of seeing that more Contra Costa children attend school regularly so they can reap the benefits of a good education.




## AAUW FUNDS Harriett Burt and Helen Pereira AAUW Funds VPs


